





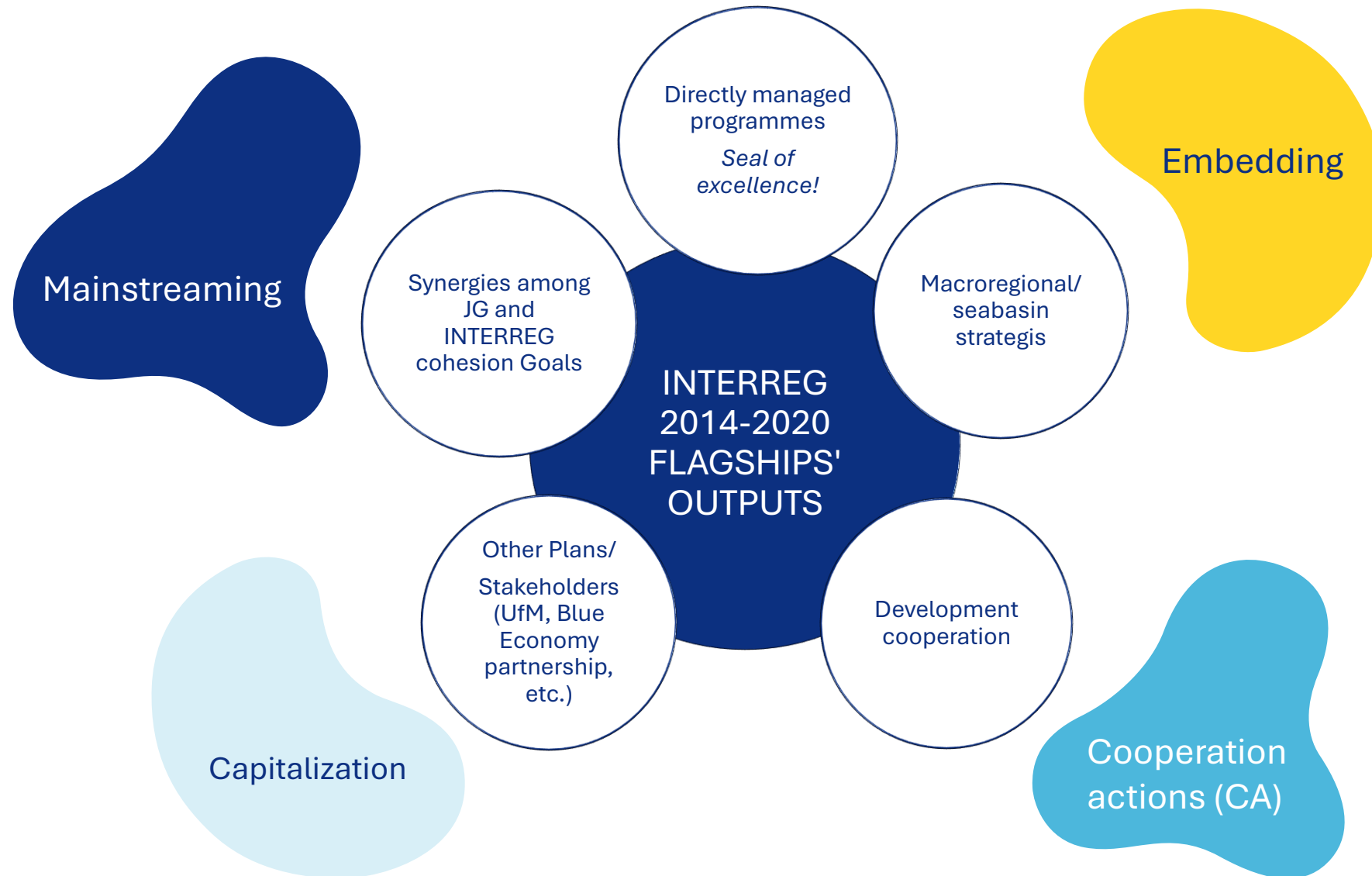

- ✓ **targeting ERDF RP MAs**

## Providing national authority support to:

5 Italian **ERDF regional MAs**, aimed at **facilitating**:

- ✓ implementation of **synergies** between Interreg and mainstream EU cohesion programmes, and beyond (Horizon!)
- ✓ contribution to **macro-regional and sea basin strategies** (MRS/SBS)
- ✓ **development of cooperation actions (CA)**





## SYNERGIES: WHY

# SYNERGIES: WHEN

Roots in the 21-27 EU cohesion programming phase (2022):

- ✓ Italian Partnership Agreement, § “Links between the 2 EU cohesion goals”
- ✓ National support delivered to ERDF regional/national MAs to comply with CPR art. 22

- ✓ Department for cohesion policies and Southern Italy (National Authority):

**Interreg Unit** (DG 5), in collaboration with the **Mainstream Unit** (DG 2)= initiator/coordinator of the process/facilitator

- ✓ The 5 Regions: Valle d'Aosta, Liguria, Friuli Venezia Giulia, Puglia, Sicily, with a **triple governance role**:

1) Mainstream **ERDF MAs= Synergies target**;

2) Interreg coordinators 3) Interreg MAs (where relevant) = **preliminary screeners of the Dpt. proposal, co-facilitators**



# SYNERGIES: HOW

METHODOLOGY IN BRIEF:

## PHASE 1

DESK ANALYSIS AND  
PRELIMINARY SCREENING

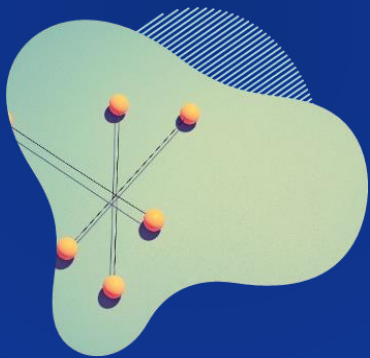
(National Authority)

- ✓ **Screening** of each ERDF regional programme **art. 22 box** on synergies/MRS/SBS and CA
- ✓ Selection of **outputs of the 2014-2020 Interreg "Flagship projects"**, identified as such by MAs according to 3 criteria: **relevance, sustainability, transferability**
- ✓ Interreg **outputs' association with each Regional Programme's SOs**
- ✓ **customised "offer" for each region, including** a selection of recently concluded **Horizon projects** in the regional territory (EC **dashboard** Horizon/Interreg)

# Synergies between cohesion and directly managed Programmes:

## Interreg as a bridge



### Sequential funding upstreamed:

using ERDF to fund actions that build R&I capacities needed to compete in Horizon Europe



### Sequential funding downstreamed:

using ERDF to fund actions that capitalise on already implemented Horizon Europe projects



### Alternative funding (Seal of excellence):

Providing ERDF to project proposals which had received a Seal of Excellence



### Complementary funding:

Bringing together funding from Horizon Europe and ERDF in the same project

### ***Phase 2) with regional Interreg coordinators/Interreg MAs:***

- ✓ **sharing of the proposed offer and additional co-screening;**
- ✓ **Survey 1 for Interreg Regions:** insight in the Regional overall cohesion, MRS/SBS, Horizon **governance**, highlight of **opportunities/obstacles**

### ***Phase 3) with REGIONAL MAINSTREAM MAs, accompanied by Interreg coordinators/MAs:***

- ✓ Screened outputs' offer, exchange in-depth on the RP;
- ✓ **Survey 2 for ERDF RP Regions:** awareness raising on opportunities for funds integration, contribution to MRS/SBS, CA; Focus on Horizon Europe

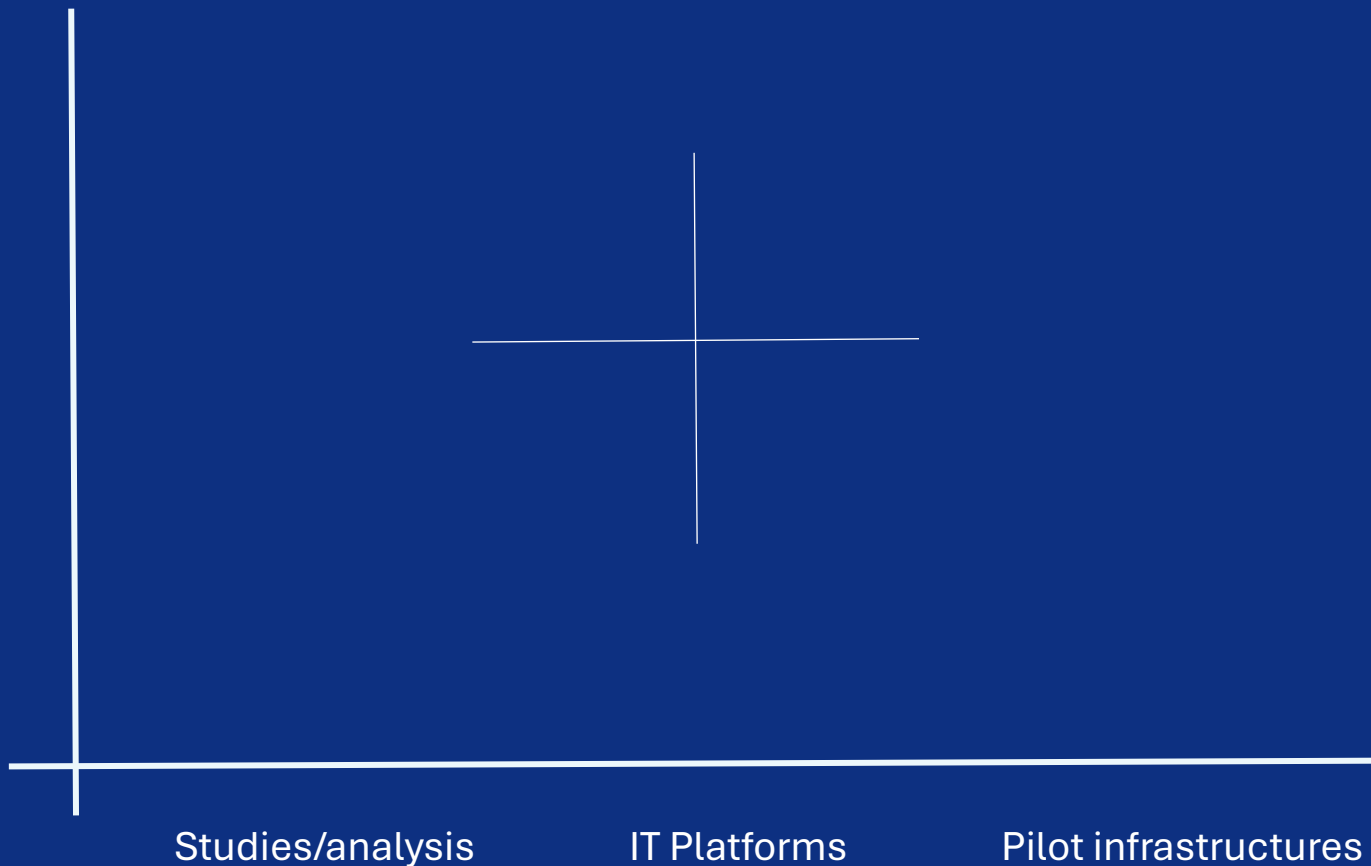
